This event has been sanctioned by the Basset Hound Club of America and is open to Basset Hounds, Beagles, and Dachshunds registered with the American Kennel Club. Spayed and neutered hounds may enter. Bitches in season are not allowed to run. Hounds will be judged by the rules used by the Basset Hound Club of America.

STAKES and ENTRIES

Stakes are limited to 20 entries each day plus alternates as time allows Open to Basset Hounds, Beagles, and Dachshunds

Stakes: Solo, Brace, and Two-Coupled Pack

Brace and Pack entries must be composed of same breed hounds Running Order Each Day: Solo, Brace, Two-Coupled Pack

ENTRIES CLOSE WEDNESDAY, August 21, 2024, at 6 PM or when all 20 entries fill Limited to 2 stakes per owner, alternates accepted

ENTRY FEES MUST BE SUBMITTED WITH YOUR ENTRY FORM TO BE ACCEPTED.

Only bitches in season will be allowed to withdraw with a full refund if the Test Secretary is notified by Wednesday, AUGUST 21, 2024.

No changes to the running order and judges will be made after rollcall, only in emergencies will changes be allowed if approved by the HPT Chair and Test Secretary.

IMPORTANT UPDATES:

Any changes to stakes (including Q, NQ selection, stake type or running mates if brace or pack) are **required** to be provided to the Test Secretary with updated/completed entry form(s) as follows:

- Changes for Friday, August 23rd test will be accepted until Wednesday, August 21st at 6 pm
- Changes for Saturday, August 24th test, will be accepted until Friday, August 23rd at 6 pm
- Changes for Sunday, August 25th test, accepted until Saturday, August 24th at 6 pm
- No changes will be allowed after the above timeframes for the applicable test date, no exceptions

Mail entries will be accepted; however, stakes are not considered guaranteed until payment is received

- Signature and entry fees must be included at time of entry
- Entry forms must be legible and clearly identify any brace/packmates and if they are running as Qualifying or Non-Qualifying
- Handlers are encouraged to use the fillable entry form included in this premium
- For each stake entered (running Qualifying or Non-Qualifying) a complete entry form must be completed/submitted with appropriate fees
- For Brace stakes and Pack stakes all dogs must be named at time of entry and the completed entry forms submitted
- Completed entry forms must be received for all the members of a Brace or Pack stake when submitting your entries
- Alternates entries owners wanting to enter more than 2 stakes, mark your entries in order of priority and include entry forms and payment for all alternate entries

OWNER/NEW OWNER INSTRUCTIONS

A dog must be entered in the name of the person who owns it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been mailed to the AKC (for complete rule, refer to Chapter 11, Section 3.)

GENERAL SITE INFORMATION, CAMPING, MEALS, PRATICE, and RAFFLES

- There will be training opportunities Thursday, Friday, and Saturday evening for registered stake holders
- Details will be provided each day
- One dog per handler
- Practice is for handlers entered and handling the dog(s) at the weekend events
- Guests that are not handling a dog for the weekend are welcome to walk the fields without a dog to observe and enjoy
- Detailed instructions will be provided each day

RAFFLE

MISCELLANEOUS

- Keep your set-up clean
- Pick-up after your dogs and do not leave trash (including baggies, water bottles, etc.) in the fields
- All dogs must be secured except when under adjudication
- The handler of a dog that kills a rabbit on the grounds under any circumstances will pay Tri-County Beagle Club \$30.00

JUDGING

- To pass, a hound must score at least 5 in each of the 5 categories and an average of 6 when all judge's scores are tallied
- Hounds will be judged using the following categories of hunting ability

(1)	ability	to	find	game

(3) line ability

(5) determination each on a

(2) use of voice

(4) adaptability

scale of 1-10 (6) pass/fail - gun shyness

SCORE SHEET PROTOCOL

- Sign your score sheets before you leave HPT grounds, or they will not be submitted for recording to the BHCA HPT Databank and the AKC
- Just as in any AKC Event the Exhibitor/Participants are responsible for the accurate recording of their dog's score
- In a BHCA sanctioned test, a Hunting Hound (HH), Senior Hunting Hound (SHH), Master Hunting Hound (MHH), or Master Hunting Hound Excellent (MHE) may be earned
 - o Each entry must specify "Q" or "NQ" indicating whether that hound is intending to qualify for a title
 - Only one "Q" entry may be submitted for each hound at a test
 - A hound must earn 3 qualifying scores in solo, brace, or 2- coupled pack to earn an HH
 - Once having the HH, the hound must compete in one of the other remaining stakes for its SHH, and then
 in the remaining stake to earn an MHH and MHE

AWARDS

- Ribbon with BHCA logo will be awarded to all qualifying hounds
- BHCA Title ribbons will be available
- BHCA logo certificate with the hound's name, owner's name, judges, date will be mailed to all hounds completing a title

EXHIBITOR INFORMATION

This test is open to hounds of the breeds specified that are registered with the American Kennel Club or have obtained ILP numbers, except for aggressive hounds or hounds suffering from any deformity, injury, or illness, which may affect the hound's physical or mental performance. Safety of the hounds is a primary concern. The test running grounds are fenced. All hounds must be always on leash except when being tested. It is expressly understood that the exhibitors alone are responsible for the behavior of their hounds, guests and children. Anyone engaging in unsafe or disruptive behavior may, at the discretion of the test committee, be asked to leave the trial site.

Bitches in season are not permitted at this test and entry fee will be refunded if a bitch entered in solo stake is in season at time of test. If a bitch in season has been entered in brace or pack, another hound may be substituted. Refunds will be given if the secretary is notified by Wednesday, August 21, 2024.

Judges are not required to wait for hounds. Owners or handlers of each hound are solely responsible for the dog being ready to perform.
